SECTION 4 - FIRST AID MEASURES

4.1 Description of first aid measures

Inhalation: If product mist or spray causes respiratory irritation or distress, move the exposed person to fresh air immediately. If breathing is difficult or irregular, administer oxygen; if respiratory arrest occurs, start artificial respiration by trained personnel. Do not use mouth-to-mouth method if victim ingested the substance. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. If unconscious, maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband. If irritation persists or if the victim feels unwell, seek medical attention.

Eyes: Immediately flush eyes with large amounts of water or saline solution for at least 15 minutes, occasionally lifting the upper and lower lids. Remove contact lenses, if present and easy to do, after first 2 minutes and continue rinsing. Seek immediate medical attention, preferably from an ophthalmologist.

Skin: Flush skin with large amounts of water while removing contaminated clothing. Wash the affected area with soap and water followed by thorough rinsing. Wash contaminated clothing before reuse. Discard contaminated shoes. Get immediate medical attention for chemical burns. If irritation persists or if the victim feels unwell, seek medical attention.

Ingestion: Rinse mouth with water if the victim is conscious. Remove dentures if present. DO NOT induce vomiting unless directed to do so by medical personnel. Vomiting may occur spontaneously. To prevent aspiration of material into the lungs, lay the victim on one side with the head lower than the waist. Never give anything by mouth to an unconscious or convulsing person. Do not leave the victim unattended. Seek immediate medical attention.

4.2 Most important symptoms and effects, both acute and delayed

Potential health symptoms and effects

Eyes: Causes severe eye irritation and serious eye damage. Symptoms include redness, swelling, tearing, pain, burns and blurred vision. May cause ulceration of the conjunctiva and cornea. This material is extremely destructive to the eyes, mucous membranes and surrounding tissue. Risk of blindness! Mist or spray may cause eye irritation. Effects may be delayed.

Skin: Causes severe skin irritation and chemical burns. Symptoms may include localized inflammation, itching and pain. Prolonged contact with unprotected skin may cause drying and cracking of the skin and/or dermatitis. Prolonged contact with unprotected skin may cause chemical burns and skin damage.

Inhalation: Harmful if inhaled. Inhalation of mist or spray may cause irritation of the respiratory system with runny nose, sore throat, cough, headache and breathing difficulty. This material is extremely destructive to the mucous membranes of the upper respiratory system. Irritation may lead to chemical pneumonitis and pulmonary edema. Aspiration of material may lead to pulmonary edema.

Ingestion: Harmful if swallowed. Causes burns to the lips, mouth, throat and gastrointestinal tract. Causes severe pain, nausea, vomiting, diarrhea, shock and possible death. May cause perforation of and permanent damage to the digestive tract. May cause circulatory system failure.

Chronic: Prolonged or repeated skin contact may cause drying and cracking of the skin, dermatitis or aggravate existing skin conditions. Chronic eye contact or exposure to mist or spray may cause conjunctivitis and eye damage. Effects may be delayed.

4.3 Indication of any immediate medical attention and special treatment needed

Advice to doctor and hospital personnel

Treat symptomatically and supportively. May cause serious burns to all body surfaces contacted. Treat as for strong alkalis. Effects may be delayed.

SECTION 5 - FIRE FIGHTING MEASURES

5.1 Extinguishing media

Suitable methods of extinction: Use extinguishing media suitable for the surrounding fire.

Unsuitable methods of extinction: No limitations of extinguishing agents are given for this material.

5.2 Special hazards arising from the substance or mixture

Closed containers may rupture due to the buildup of pressure when exposed to extreme heat. During emergency conditions overexposure to decomposition products may cause a health hazard. Symptoms may not be immediately apparent or may be delayed. Obtain medical attention.

Explosion hazards: This product is not considered an explosion hazard.

5.3 Advice to firefighters

Full protective equipment including self-contained breathing apparatus should be used. Water may be used to cool closed containers to prevent pressure buildup and possible autoignition or explosion when exposed to extreme heat. Water contaminated by this material must be contained from being discharged to any waterway, sewer or drain to prevent environmental contamination.

SECTION 6 - ACCIDENTAL RELEASE MEASURES

6.1 Personal precautions, protective equipment and emergency procedures

Evacuate non-essential personnel. Wear appropriate protective clothing and equipment designated in Section 8.2. Ventilate the area. Remove all sources of ignition. NO SMOKING. Clean up spills immediately. Spill creates a slip hazard.

6.2 Environmental precautions

Avoid dispersal of spilled material or runoff and prevent contact with soil and entry into drains, sewers or waterways.

6.3 Methods and materials for containment and cleaning up

Approach spill from upwind direction. DO NOT flush large spills down the drain. Cover drains and contain spill. Cover spill with a large quantity of inert absorbent. Do not use combustible material such as sawdust. Collect material and place into an approved container for proper disposal. Observe possible material restrictions (Sections 7.2 and 10.5). Do not allow material or runoff from rinsing contaminated areas to enter floor drains or storm drains and ditches that lead to waterways. Dispose of via a licensed waste disposal contractor.

SECTION 7 - HANDLING AND STORAGE

7.1 Precautions for safe handling

Wear all appropriate personal protective equipment specified in Section 8.2. Do not get in eyes or on skin or clothing. Do not inhale mist or spray. NO SMOKING. If normal use of material presents a respiratory hazard, use only adequate ventilation or wear an appropriate respirator. Wash contaminated clothing thoroughly before reuse. Discard contaminated shoes.

7.2 Conditions for safe storage, including any incompatibilities

Store in dry, cool, well-ventilated areas away from incompatible materials (see Section 10.5), food and drink. Keep away from acids. Do not store in metal containers. Keep from freezing. Transfer only to approved containers having correct labeling. Keep containers tightly closed when not in use. Protect containers against physical damage. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Containers are hazardous when empty as they contain product residue. Use appropriate containment to avoid environmental contamination. Ventilate closed areas. Keep locked up and out of reach of children.

8.2 Exposure controls

Engineering measures: Technical measures and appropriate working operations should be given priority over the use of personal protective equipment. Use adequate ventilation. Local exhaust is preferable. Refer to Section 7.1.

Individual protection measures: Wear protective clothing to prevent repeated or prolonged contact with product. Protective clothing needs to be selected specifically for the workplace, depending on concentrations and quantities of hazardous substances handled. The chemical resistance of the protective equipment should be enquired at the representative supplier.

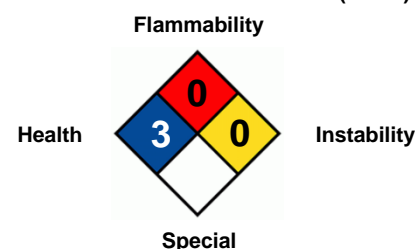
